

Iloilo Dinagyang Photo Contest 2011

Contest Rules and Mechanics

- **PHOTO ELIGIBILITY** -This contest is open to all professional & amateur photographers and hobbyists ages 18 and above. Contestants below 18 years old should have written permission from his/her parent or guardian.
- **CATEGORIES** – There are now **two categories** for the Dinagyang Photo Contest 2011:
 - I. **“Ati” Contest Category**
 - The subject can be either an “Ati” or a tribe or any Dinagyang participant during the “Ati” Contest on **January 23, 2011 (Sunday)**. Please note that deliberately posed shots are strongly discouraged.
 - II. **Religious Category**
 - The subject can be any event or activity in Iloilo City that connects the weeklong Dinagyang celebration with its religious roots. Photo entries should be taken only **from January 17 to 23, 2011**.
- **Criteria for Judging (for both categories)**
 - Visual Impact : 30%; Technical Aspect (exposure & focus) : 30%; Artistic Aspect (creativity & composition) : 40%. Total : 100%.
- **PHOTO FORMAT / ENTRY DETAILS**
 - Each entry must be taken with a digital or film camera and submitted in either **an 8"x10" or 8"x12"** color print without border. Digital entries must also submit the digital file (either on JPEG, TIFF or Raw) on a CD on actual size with **150 dpi resolution or higher**. Corresponding negatives should accompany film entries.
 - All photographs should accurately reflect the subject matter and the scene as it appeared. Photos that have been digitally altered or manipulated beyond standard optimization (e.g. cropping, reasonable adjustments to exposure, color and contrast, etc.) will be disqualified. Images that do not meet these requirements may or may not be judged at the judging panel's sole discretion.
 - A participant is allowed a maximum of **five (5) entries per category**. The **entry fee is P120 per photo** submitted.
 - Participants should write on a piece of paper their name address and phone number taped to the back of all their photo entries. Entries, together with the digital file on CD or film negative, should be submitted in a sealed long size brown envelope.
 - **Deadline** for submission of entries will be on **January 31, 2010**, 5:00 p.m. at **PHILIPPINE RED CROSS - ILOILO CHAPTER**, Bonifacio Drive (behind the Hall of Justice), Iloilo City. Tel. No (033) 337-5950.
 - By submitting an entry, each participant agrees to the Official Rules and warrants that his or her entry complies with all requirements set out in the Official Rules.
- **USE RIGHTS**
 - By entering the contest, participants grant the Iloilo Dinagyang Foundation, Inc. a royalty-free, world-wide, perpetual, non-exclusive license to display, distribute, reproduce, and create derivative works of the entries, in whole or in part, in any media, for any educational, promotional, exhibition, archival, and all other standard purposes of the Foundation. Any photograph reproduced will include a photographer credit as feasible. The Iloilo Dinagyang Foundation, Inc. will not be required to pay any additional consideration or seek any additional approval in connection with such uses. All prints & CDs submitted shall be the property of the Iloilo Dinagyang Foundation, Inc.
- **EXHIBIT & AWARDING**
 - Pre-screened entries will be exhibited (tentatively) on **February 7, 2011**. The awarding of winners will also be held on the same day. Venue of the exhibit and awarding of winners, as well as prizes, will be announced later.
 - The Organizer reserves the right to disqualify a winning entry for non-compliance of the rules mentioned above.
 - The decision of the Board of Judges is Final. The organizer shall have the right not to entertain any protest or complaint after the final decision of winners shall be made.
